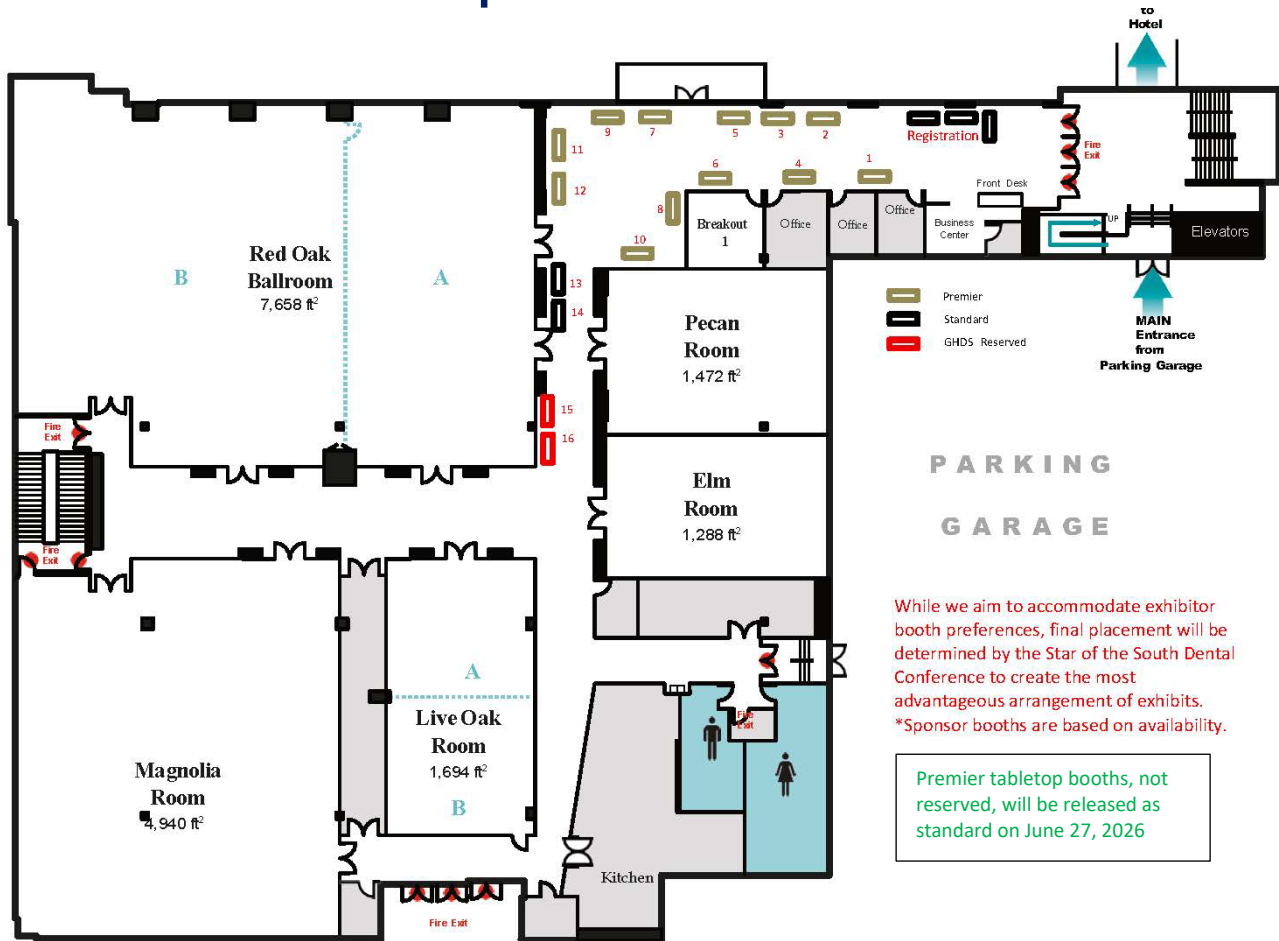

Exhibit Contract Terms and Conditions

Application Approval

All applications are subject to approval by the Greater Houston Dental Society (GHDS). The GHDS may accept or reject any application to exhibit in its sole discretion, and has full and final authority to interpret, amend or supplement these Guidelines, Rules and Regulations. The Star of the South Dental Conference reserves the right to cancel this contract if an exhibitor displays, sells a product which is not authorized by the show management after being notified to discontinue such display or sale; or breaks any other regulation. In such event, all payments previously made on this contract are non-refundable. The Star of the South Dental Conference and the Greater Houston Dental Society shall be released from all claims for damage, loss, costs, or expenses sustained or incurred by the exhibitor by reason of such cancellation.

Cancellation Deadline

Cancellations received prior to August 14, 2026, are eligible for a **50% refund**. Cancellations received after August 14, 2026, **are not eligible for refund**. All cancellations must be made in writing via email to cbolls@ghds.org.

Booth Specifications

The Star of the South offers tabletop exhibits. Each table booth includes: 2 exhibitor name badges, a standard 6-foot table, two chairs, and a small ID tabletop sign. The floor is carpeted, and electricity is available if ordered in advance. Complimentary internet is available. Tabletop exhibit booths must remain in their original location, and only the provided chairs and 6-foot table may be used. Additional tables, including cocktail rounds provided for attendees, are not permitted for use by exhibitors.

Exhibitor Registration

Exhibitors may register up to 2 booth personnel per table booth space purchased. No Additional personnel will be allowed. All personnel names must be submitted with the contract. The name badge issued upon check-in / setup must be worn at all times during the show.

Restrictions

Exhibiting company shall use its booth space solely and exclusively for the exhibition of material, equipment, or services normally manufactured, distributed, or furnished by it in the regular course of its business, and for no other purpose. Exhibitors rendering badges to unauthorized persons shall forfeit their exhibit space without eligibility for a refund and future exhibition privileges. The exhibitor shall not assign sublet, license, or otherwise release, transfer, apportion, or dispose of its exhibit space, name badges or any part thereof. Non-exhibiting companies and their representatives are not allowed at any function or activity at the Star of the South Dental Conference. Violators will be asked to exit the premises. Two companies, whether or not they represent or distribute each other's products, may not occupy one 6' tabletop booth.

Exhibitors shall not display noisy electrical devices, sound equipment, or other devices that interfere with other exhibits. Playing live or recorded music is prohibited.

All business activities of the exhibitor must be confined to the rented table space. No business activities are to be undertaken in any aisles, lobbies, or other areas of the conference center. Exhibit tables must be staffed throughout the posted show hours.

Conducting live clinical procedures on patients or live models is prohibited.

Exhibitors shall not place any equipment that interferes with the exposure of any other booth or impedes free use of the aisle. Displays shall not block the diagonal line-of-sight (above four feet) to the front of any contiguous booth.

The Star of the South has developed these exhibit regulations to provide a well-balanced, well-regulated, attractive, and successful event. No exceptions to these regulations will be permitted. The Star of the South reserves the right to enforce strict compliance with these Exhibit Regulations:

Insurance

Exhibiting company agrees to carry insurance for a single limit of not less than \$1,000,000 for its employees, agents, contractors, and representatives present at The Star of the South Dental Conference in each of the following categories: Broad Form General Liability and

Automobile Liability. The exhibitor agrees to provide Workers' Compensation Insurance providing benefits for the state of Texas and Employers' Liability of \$100,000 per accident. An umbrella liability policy would be satisfactory provided all these areas are covered. The policy must name as additional insureds: The Star of the South Dental Conference; Greater Houston Dental Society; and the Norris Conference Center. Exhibitor must provide a Certificate of Insurance showing the policy in effect through September 26, 2026. **EXHIBITORS MUST PROVIDE PROOF OF INSURANCE NO LATER THAN SEPTEMBER 11, 2026.**

Shipping

If you or a supporting company need to ship supplies or materials to and from the meeting, you or the sponsoring company will be responsible for payment and making the necessary arrangements with the shipping company of your choice. The Norris Conference Center will not accept C.O.D. Shipments. Shipments are to arrive no more than three days before the event. Deliveries must be addressed to:

Any leftover materials and supplies must be removed by you upon your departure on Saturday, September 26, 2026. If shipping, you must make arrangements for it to be picked up on Monday September 28, 2026 between 8:00 am and 5:00 pm, complete the required paperwork and return shipping labels and drop it off at the front desk. **The Star of the South will not be responsible for discarding any material or payment of shipping fees.**

Indemnification and Liability

The exhibiting company, its agents, employees, contractors, or representatives assumes and agrees to indemnify, protect, save and hold harmless the Star of the South Dental Conference, the Greater Houston Dental Society, the Norris Conference Center, its agents, employees, contractors or representatives, from and against any and all losses, damages, injuries, claims, demands and expenses, including legal expenses, of whatsoever kind or nature, arising due to the exhibitor's conduct or negligence during participation in show, including installation and dismantle periods. **NOTE: Absolutely no children under age 18 are allowed in or near the exhibit area during exhibitor move-in and move-out hours.**

Security

Security will not be provided. The Star of the South Dental Conference, the Greater Houston Dental Society, or Norris Conference shall NOT be held responsible for any loss or damage to equipment, materials, or products within the exhibit area. It is the responsibility of the exhibitor to provide for any damage or losses of any kind to the equipment, materials, or products on display. The GHDS does not insure exhibitors for loss by theft or otherwise. The GHDS is not responsible for loss or damage resulting from any cause in connection with transfer, installation, maintenance, or removal of exhibits, or management of the convention. Exhibitors wishing to insure their goods must do so at their own expense.

Miscellaneous

On all matters not herein covered, or any differences, final decisions are subject to the judgment of the Star of the South Dental Conference and the Greater Houston Dental Society.
